


### **Advocate Monthly Top Ten**

Emily, our General Common Law caseworker, will be joining Four Brick Court in October:

# Fulfilling multiple goals through a single action: Adam Al-Attar KC's barrister story



Advocate panel member and reviewer Adam Al-Attar KC of South Square reflects this month on how a simple recommendation from a senior colleague led to a rewarding journey volunteering with Advocate.

As a reviewer, Adam describes the experience as intellectually stimulating and professionally worthwhile due to the diverse range of cases that come through, even within specific practice areas.

Adam also highlights the professional value of pro bono work, particularly for commercial

practitioners and those looking to apsilk: "For commercial practitioners, p is an opportunity to evidence excelled diversity, , as the range of circumstal and cases encountered through pro I work is often much broader than tho through paid clients".

He encourages other barristers to ge involved, either by reviewing or takin cases, and points to schemes such as Chancery Litigant in Person Support Scheme as rewarding ways to give by while developing professionally.

### **Katie Stephens** St Philips Chambers

Our thanks to Katie Many thanks to Will Baylis-Allen of MILS Legal Ltd for assisting our applicant in the **Employment Appeal** Tribunal. Our applicant had been dismissed as a Sales Associate from a luxury designer brand, and claimed unfair dismissal, racial discrimination and whistleblowing against the company. Her claim form was initially dismissed by the Employment Tribunal for supposed procedural inaccuracies. Will represented her at the **Employment Appeal** Tribunal and was successful in appealing the Tribunal's rejection. The Judge upheld the appeal in full and substituted the previous Judge's decision, allowing the applicant's claim form to be accepted

Dr Niaz Shah Nexus Chambers

Stephens of St Philips Chambers for assisting our applicant, a husband who was in long-running family financial proceedings. The husband had approached Advocate after separating from his wife and being left in a dire financial position. He sought a new equitable consent order due to inaccuracies in what had initially been agreed, including over the pension order. Katie assisted him at their final hearing, in which she successfully argued against a Pensions on Divorce Export report. Her advice and representation resulted in the court making a pension sharing order in favour of the husband, making a significant difference to his financial position.

Thank you to Dr Niaz Shah of Nexus Chambers for assisting our applicant, a mother from Pakistan, in her case concerning her application for an EEA family permit. Her application had been refused, with the First-tier Tribunal and the Upper Tribunal failing to fully consider the full grounds of her application. Niaz Shah assisted her with drafting her skeleton argument and represented her at the hearing in the Court of Appeal to address her permission to appeal.

Thanks to Niaz's assistance, the appeal was allowed, with the matter now remitted to the Firsttier Tribunal so that her application for an EEA permit to join her family can be reconsidered.
