In March, barristers across England and Wales will be renewing their practising certificates through the MyBar portal. When doing so, there is an opportunity to donate £35 or more to Advocate. Ahead of practising renewal opening, our CEO Rebecca Wilkie has written a blog about why these donations mean so much to sustaining our service.

Rebecca shares how Advocate has seen a dramatic increase in requests for help to our service in the last year, receiving an average of 31 applications per working day in 2024. Alongside the increase in demand for support however, she highlights that we have also seen an increase in barristers taking on pro bono work and donating to us, with over 7,000 barristers generously donating to us during practising renewal last year.

#### TrustLaw Index of Pro Bono

This month, <u>Thomson Reuters</u> <u>Foundation</u> published the TrustLaw 2024 Index of Pro Bono. Now in its sixth iteration, the report maps global pro bono trends gathered from 209 law firms in 123 jurisdictions (comprising almost 100,000 lawyers).

Headline figures showed that 57% of lawyers worldwide are now engaged in pro bono work, donating an average of 35.6 hours over the year. The report revealed growing attention to certain causes to respond to critical needs (e.g. immigration and refugees, climate change), the growing formalisation of pro bono, and increasing attention to the "business case" for pro bono relating to staff training and skills, marketing, and alignment with client interest.

## Young barrister story -

## Abdallah Barakat



"Access to justice is the fourth pillar of the welfare state, along with healthcare, education and social security. It is a right and not a privilege. In my view, those who provide legal services owe society a duty to lend their skills and expertise to those who need but cannot afford or otherwise access them."

This month, Abdallah Barakat of 9 Park Place Chambers in Cardiff, shared his pro bono story with us. Abdallah is a young barrister who has been dedicated to pro bono work ever since volunteering with the Cardiff University Innocence Project as an undergraduate student.

Abdallah reveals his passion for pro bono work and why he made it an integral part of his practice since his pupillage. He also offers insights into how others can get involved in pro bono work through Advocate, drawing particular attention to the critical need for greater pro bono legal support in Wales.
