#### Collaborate – a case-based mentoring scheme

Advocate's case-based mentoring scheme enables those who feel they would like additional support when taking on pro bono cases to benefit from general advice and support from senior barristers. You might be interested in receiving mentoring if you are a second six pupil, a junior barrister, taking on cases in new areas of law, or even returning from a career break.

We asked Jagoda Klimowicz, of Brick Court Chambers, to share on Collaborate

and her experience of mentoring with Sebastian Naughton, of Serjeants' Inn Chambers. They both found the experience beneficial for their pro bono practice. Jagoda highlighted the benefit of learning from Sebastian's knowledge of the practicalities in the Employment Tribunal and Sebastian emphasised he would recommend becoming a Collaborate mentor, as he found it an easy way to give back and make pro bono work part of his practice.

# 6 Duty Schemes

### We've been scheming...

The Chancery Litigant in Person Scheme (CLIPS) is running successfully in London and Newcastle, and with the help of local chambers, we are also

In January we employed a new member of the team to focus on duty schemes. Over the past few months Jessica has worked on improving the running of our existing pro bono schemes, increasing our involvement in court duty schemes, and setting up new schemes. Most notably, the **Court** of Appeal Scheme is now back up and running. We have seen an increase in applications from litigants in person making permission to appeal applications. This has been met with equal enthusiasm from volunteers who have signed up to assist. Volunteers provide initial merits assessment and, if merit, draft a skeleton argument for litigants in person to submit with their applications. There is also the option to assist with any hearings that might be granted. A fantastic opportunity for those looking to build on their experience in the Court of Appeal.
