


## **Advocate Monthly Top Ten**

# New Partner Scheme opens doors for barristers in Competition Appeal Tribunal (CAT) work



Advocate is pleased to announce the launch of a new pilot scheme, in collaboration with the Competition Appeal Tribunal to provide free legal assistance and representation to litigants in person before the Tribunal.

Running for an initial period of 18 months, the Scheme aims to improve access to justice for individuals and organisations involved in complex competition law proceedings who would otherwise be unrepresented.

This is a developing and important area of law that helps to regulate businesses and prevent unfair and abusive practices, such as price-fixing or monopolisation. The scheme is supported by a panel of almost 70 volunteer barristers, all of whom are committed to delivering high-quality pro bono support.

Sarah Abram KC, who has spearheaded the scheme, has said:

"Competition law isn't just an issue for major companies; anyone in any walk of life can be affected by a competition law problem, including consumers, small businesses and charities. The cost of bringing a claim shouldn't be a deterrent. Sincere thanks to the 70 barristers who have signed up as panel members for the scheme".

## Shout out to Panel Members...

Thank you to Juan Lopez of 39 Essex Chambers for helping a woman - a flat leaseholder - in a property dispute concerning alleged service charge arrears. The landlord had filed a claim for significant arrears despite the person asserting that the landlord had consistently failed to provide adequate services or carry out essential repairs and maintenance works in breach of covenant, and had also wrongly rejected a crossclaim made for equitable set-off in connection with requested rectification. Juan stepped forward to assist, at very short notice, drafting a skeleton argument and attending the final hearing at the First-tier Tribunal (Property Chamber). Thanks to his assistance, a favourable settlement was reached. This is a further piece of pro bono work that Juan has taken on through Advocate within recent months, helping a number of people in urgent need of help.

We would like to thank Kendva Goodman of Maitland Chambers for assisting a single mother on universal credit who was being pursued by her ex-in-laws for monies they had advanced to her and her ex-partner before the partnership broke down in distressing circumstances. Her case was that it was a loan made between family members, with no legal effect. Repayments had been paused in 2021 to allow the couple to save for their wedding, but upon the divorce, the defendant's ex-in laws issued a claim against her for the balance of the loan. This came as a great shock to the defendant, whose divorce settlement had not provided for such a liability, and who did not expect to be further embroiled in proceedings while caring for a young child. Kendya advised the defendant on her legal position and successfully assisted her to navigate the pre-trial process and to pursue a settlement. The claim has been settled in full, and the trial is now
