



Advocate is thrilled to announce that, thanks to an incredible show of support from the Bar, it placed a record-breaking 1,412 pieces of pro bono work with barristers in 2020.

This wonderful news comes at the start of Advocate's 25th anniversary year. Despite barristers suffering terrible upheaval due to the Covid-19 pandemic, 470 people signed up to Advocate panel to help vulnerable applicants receive advice, drafting and representation when they needed it most. This is an impressive 86% increase on last year and their enthusiasm enabled us to place almost twice as many cases than in 2019.

We are honoured to have such magnificent support from our Advocate panel members and the wider Bar. We are aware of the outstanding amount of work that barristers all over the country give in support of access to justice, making a real difference to people's lives.
