Inaugural Launch of the Displaced Journalists Initiative

The Displaced Journalists Initiative (DJI) was launched on 17 July 2023 by <u>Talent Beyond Boundaries</u> (TBB) and <u>Doughty Street Chambers</u>.

Since the Taliban takeover,
Afghanistan has lost almost 40% of
media outlets and 60% of journalists,
according to Reporters Without
Borders (RSF). In response, the DJI was
formed to support employers and
organisations wishing to recruit
talented displaced journalists.

TBB is a global non-profit organisation working to connect skilled refugees, such as journalists, with employers.
TBB developed the Displaced Talent Mobility Pilot with the UK
Government, which enables priority processing of skilled worker visas and safeguards talented workers.

The launch event highlighted existing work with a group of Afghan journalists and how the DJI can be used to relocate them and their families to safety.
