The mother applied to Advocate following the father retaining the child and refusing her access. There were allegations of parental alienation and emotional abuse. The mother was looking for advice and representation for the final hearing, and Jack stepped up to assist. The mother and Jack explored every avenue but

ultimately, the mother decided to withdraw from the proceedings with the child's welfare at the heart of her decision. The mother wrote to both Advocate and to Jack to express how grateful she was for the support she received during what has been a highly emotional and challenging time for her and her family.

Thank you to Kate Balmer and John Platts-Mills of Devereux Chambers for assisting our applicant in a long-running racial discrimination claim against his employer. In the Employment Tribunal, the employer had denied all allegations of discrimination, and the **Employment Tribunal** dismissed the discrimination claims. Our applicant appealed to the **Employment Appeal** Tribunal on the basis that the Employment Tribunal had erred in law in its analysis of time limits and whether the conduct in question related to race. John assisted with advice and representation at the appeal sift stage. Kate then provided pro bono representation at the final **Employment Appeal** Tribunal hearing, where she was successful in overturning the Tribunal's findings for two serious claims of race-related harassment. Our applicant was hugely grateful for their support, writing to us to say: "This overturning
