[The Pro Bono Recognition List of England and Wales](#) is a newly launched, cross-profession initiative, set up collaboratively by the Attorney General's Pro Bono Committee, the Bar Council, the Law Society and all major pro bono organisations including Advocate.

The Recognition List, endorsed by the Lady Chief Justice, is set to become an annual acknowledgement of all pro bono work happening across the legal profession, both by barristers and solicitors.

The Recognition List recognises pro bono work undertaken in the previous calendar year, so if you are a barrister who completed 25 or more hours of pro bono work in 2023, and would like to have your contribution reflected in the first ever Pro Bono Recognition List (set to be published in June of this year), please fill out [this form](#). In addition to appearing on The Recognition List, you will also be sent a celebratory logo for your email signature and Chambers profile. The deadline for submissions is **Friday 24th May 2024**.

If you did not manage to reach 25 hours of pro bono work last year, there is still time to get ahead for next year's list. If you have already completed 25 hours of pro bono work since the start of the year, fill out [this form](#) to submit your name for the Recognition List to be published next year!
