

Support the Bar's pro bono charity

Please donate £35 to Advocate when renewing your practising certificate

The Authorisation to Practise portal is now open!

Every year, Advocate asks the Bar to donate when renewing their practising certificates. The donations we receive through this process make up almost 50% of our annual funding, making it a lifeline for our survival and for those in need of the Bar's pro bono help.

The demand for our service has reached an all-time high. Applications for help grew by 24% in the last six months of 2023. In January 2024 alone, we received 348 new applications for help, the highest number ever received in a month in our organisation's history. As the cost of living crisis continues to take its toll on people with already limited financial resource, legal costs are out of the question. We anticipate this need to only grow further in the months to come.

Your support makes a real impact. One of our applicants recently told us: *"I am immensely grateful to Advocate for all the assistance that you have provided to me. Your help has made such a huge difference to the outcome of my case as well as to my mental wellbeing. I don't know if I could've made it so far without the support of all the brilliant barristers that have represented me on numerous occasions."*

We are grateful to the growing number of barristers who donate their time to pro bono. The 2023 Barristers' Working Lives survey (taken from 3,237 barristers) found that 49% of barristers had undertaken pro bono work last year, a 14% increase since 2021. This is a testament to the Bar's commitment to access to justice.

We are also hugely thankful to those of you who may not be able to do pro bono work but can donate to Advocate and support our service this way. Many of you do both, which we are immensely grateful for. **We simply would not exist without your support.**
