Welcome back from Sharif A. Shivji KC, Chairman of Advocate

Welcome back and happy new year – I hope you are looking forward to this year as much as we are at Advocate.

I would like to take this opportunity to thank all of you who supported us last year. Be that through volunteering, mentoring or donating, you have all made an impact to Advocate and the members of the public who we support.

Nothing illustrates this better than when we look back on the demand we received for our service last year. We experienced an almost 15% increase in fresh applications compared to 2022, and in the last six months of 2023 it was a 24% increase compared to the same six months in the previous year. Over the whole year, we placed over 1,200 cases through our core

casework service, and many more through our pro bono duty schemes. We could not have done this work without your support - thank you.

Exeter Family Law Clinic Launch

This month we were delighted to launch the Exeter Family Law Clinic alongside CASS+.

This new scheme will support litigants in person (LIPs) in the South West who have proceedings, or are considering proceedings, in Private Family Law or under the Family Law Act.

Barristers volunteering at the clinic will provide 40 minute pre-arranged appointments to provide advice on areas such as merit, understanding proceedings and next steps.

We launched the scheme at an event kindly hosted by Exeter County Court, with support from the Western Circuit. We were delighted that the local judiciary, Bar, law firms, law students and other frontline organisations were also in attendance.

HHJ Horton highlighted the important role that pro bono schemes play in supporting LIPs in the South West and Charlotte Mallin-Martin of <u>Guildhall</u> <u>Chambers</u> ran through the practicalities of the scheme. Other discussions focussed on the role that frontline

organisations play in facilitating pro bono in the region and how barristers can get involved.
