


The Guide to Pro Bono for the Employed Bar

We produced this guide in partnership with the Bar Council, the Bar Association for Commercial, Finance & Industry, FRU, the In House Pro Bono Group and the Government Legal Department.

The Guide provides practical steps for how employed barristers with practicing certificates can undertake pro bono, and the key practical factors to consider when doing so.

Launch of the Access to Justice Committee

The event welcomed the launch of a new pro bono guide, which is a directory for MPs and others looking to signpost individuals to free legal and other advice.

On 20th June, we attended the launch of the new All-Party Parliamentary Group (APPG) on Access to Justice in the House of Lords.

The Group will be Co-Chaired by Karen Buck MP and Laura Farris MP, and brings together two cross-party parliamentary groups: the Legal Aid APPG and the Pro Bono and Public Legal Education APPG.

The event was attended by representatives from across the justice sector, with speeches from the Co-Chairs and the Lord Chancellor and Secretary of State for Justice, Alex Chalk. The Lord Chancellor previously chaired the Pro Bono APPG when it was relaunched in 2016.
